ANNOUNCED SUPPORT FOR BUSINESSES AND INDIVIDUALS AFFECTED BY FLOOD

WA natural disaster of unprecedented proportions has wreaked havoc across South-east QLD and North-eastern NSW. Thousands have been displaced by storms and severe flooding resulting in loss of homes, businesses and most tragically loss of life.

Both the State and Federal governments have announced financial support for individuals and businesses for those affected. The Federal Government Payments include:

- Disaster Recovery Payment \$1,000 per eligible adult and \$400 per eligible child if your home has been severely damaged or destroyed, or you've been seriously injured.
- Disaster Recovery Allowance short-term income assistance (up to 13 weeks) if you've lost income as a direct result of the floods.

WAGE SUBSIDIES

With the downturn in immigration, international students and travellers, many businesses are struggling to find employees. And with the short supply of workers, some employees are now asking for well above award payment. Any financial assistance with payroll is greatly appreciated, so you may consider looking at the Government's Wage Subsidy program.

The Government increase the maximum amount offered to \$10,000 in July 2021, but this amount will only be available until 31 June 2022.

Wage Subsidies are a financial incentive to encourage employers to hire eligible participants in ongoing jobs. The eligible participants are registered with employee service providers (for a minimum of 12months) and are:

- 15 to 29 years of age,
- Indigenous Australians,
- 50 years of age and over, or
- a parent
