# SUPERANNUATION GUARANTEE CHARGE STATEMENT

We all know that Superannuation Guarantee (SG) is a mandatory quarterly payment made to your employees Superfund. But do you know what is required of you if you are unable to make this minimum payment on time?

If you are unable to pay your employees SG full amount on time and to the correct fund, you are required to pay the Superannuation Guarantee Charge (SGC) and lodge the SGC statement with the ATO. The payment of SGC and lodgement of the statement is due one month after the SG due date. le. December SG is due on 28th January, if you do not meet your obligations by this date, you must lodge and pay SGC by 28th February.

The SGC is made up of 3 amounts:

- 1. the SG shortfall, made up of:
- i. super calculated on salary and wages (including any overtime)
- ii. any choice liability, based on the shortfall and capped at \$500
- 2. nominal interest of 10% per annum (accrues from the start of the relevant quarter)
- 3. an administration fee of \$20 per employee, per quarter.

These additional charges can add up quickly, which is why we encourage (and sometimes nag) all our clients to pay and lodge their SG by the due date.

The SGC Statement can be lodged via the ATO portal, or a hardcopy can be mailed to the ATO. The ATO provide the form and a calculation tool on their website to assist you in the process. And of course, Pacific Accounting are here to help. We can calculate your SGC and make the lodgement for you. We can also assist in payment plans for SGC if needed.

### **SECURE JOBS, BETTER PAY**

The Australian Governments Fair Work Legislation Amendment (Secure Jobs, Better Pay) Act 2022 has now passed. This legislation amends the Fair Work Act to change several existing rules and introduces a range of new workplace laws.

The amendments start on different dates and key changes can be found at the Fairwork website or on the timeline below:

# 2023

#### 7 January

- Job advertisements can't include pay rates that would breach:
  - the Fair Work Act. or
  - a fair work instrument (such as an award or enterprise agreement)

#### 6 February

 Abolition of the Australian Building and Construction Commission (ABCC)

#### 6 March

- Prohibition of sexual harassment in the workplace
- Creation of 2 expert panels at the Fair Work Commission to focus on pay equity and the care and community sector

#### 6 June

- Changes to agreement making
- ✓ Increased access to multiemployer bargaining through:
  - single-interest bargaining
  - supported bargaining
  - cooperative bargaining
- Changes to extending unpaid parental leave, including giving the Fair Work Commission the power to deal with disputes
- More employees being able to access flexible working arrangements
- ✓ Abolition of the Registered Organisations Commission (ROC), with its functions moving to the Fair Work Commission

#### 1 July

- ✓ Creation of the National Construction Industry Forum
- ✓ Increase in monetary cap for recovering unpaid entitlements via the small claims process

#### 6 December

- Limiting the length of fixed term contracts, with the Fair Work
   Commission having powers to deal with disputes
- → Requirement to give Fixed Term
